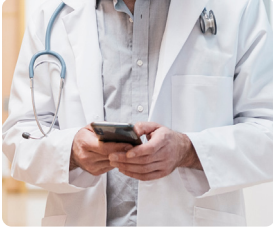

STEP 1

Set your own prices

Share your cash price for Sidecar Health® patients. Our members can compare providers' prices in the Sidecar Health app.



STEP 2

Get paid at time of service

Our members pay providers at the time of service using the Sidecar Health VISA benefit card.



STEP 3

Provide patient with a superbill

Patients will load their superbill (itemized medical invoice) into the Sidecar Health app for processing.



STEP 4

That's it, you're good!

How will I get paid?

You will be paid in full at the time of service. Members will pay using the Sidecar Health VISA benefit card.

How much does this cost for my patients?

What should be included on a superbill?

- Patient's full name
- Provider's name, address, and NPI
- Date of service
- Itemized charge amount(s)
- Procedure codes (CPT / HCPCS)
- Diagnosis codes (ICD-10)
